Motion by Hinrichsen seconded by Abell to approve the agenda. Motion carried unanimously.

Motion by Hinrichsen seconded by Abell to approve the consent agenda. Motion carried unanimously. The consent agenda included minutes from the November 17, 2025 regular meeting and the December 4, 2025 work session. Resignations included Chad Hinrichsen as Jr. High Football Coach. Staff Contract/Letter of Assignment approvals were Pat Baltes as Volunteer Driver (Girls Wrestling) and Alex Baltes as Assistant Wrestling Coach.

Motion by Hinrichsen seconded by Abell to approve the Bills and Financial Reports. Motion carried unanimously.

Motion by Hinrichsen seconded by Abell to adjourn the meeting at 5:47pm. Motion carried unanimously.

#### Organizational Meeting for 2025-2026

Motion by Abell seconded by Hinrichsen to have regular scheduled board meetings on the third Wednesday of the month at 5:30 pm. Motion carried unanimously.

Motion by Abell seconded by Hinrichsen to appoint Angie Putz as Board Secretary and Holly Fischer as Board Treasurer. Motion carried unanimously.

Motion by Abell seconded by Hinrichsen to approve Angie Putz and Christina Schlader along with the Board President Hillman as the authorized signers for the district. The district's bank accounts are: General, Management, PPEL, SAVE, Capital Projects, Nutrition, Daycare and Activity Funds. Motion carried unanimously.

Motion by Abell seconded by Hinrichsen to approve Ahlers and Cooney as the board attorney firm for the coming school year. Motion carried unanimously.

Motion by Abell seconded by Hinrichsen to approve First Security Bank and Iowa School Joint Investment Trust (ISJIT) as the official financial depositories up to the amount of \$10,000,000.00. Motion carried unanimously.

Motion by Abell seconded by Brokel to appoint Bobbi Hinrichsen as the board representative to vote on behalf of the RRMR School Board for the Floyd County Conference. Motion carried unanimously.

Motion by Hinrichsen seconded Abell to approve board members Heather Brokel and Justin Abell to be on the negotiations committee. Motion carried unanimously.

Motion by Abell seconded by Hinrichsen to approve the following coordinators: Nick Johnson as Equity Coordinator, Travis Pike as Homeless Coordinator, Travis Pike as 504 Coordinator, and Nick Johnson as Affirmative Action Coordinator. Motion carried unanimously.

Motion by Abell to approve the request to the School Budget Review Committee (SBRC) for the Modified Supplemental Amount (MSA) in the amount of \$110,958.00 for the 2026-2027 At Risk/Dropout Plan. Seconded by Hinrichsen. 4 Ayes, 0 Nays. The motion passes by a vote of 4 -0.

Motion by Hinrichsen to approve the At-Risk/Dropout Plan for the 2026-2027 school year. Seconded by Abell. 4 Ayes, 0 Nays. The motion passes by a vote of 4-0.

Motion by Hinrichsen seconded by Abell to adjourn the meeting at 6:04 pm. Motion carried unanimously.
